Would you like to benchmark your livestock business and contribute to the progress of the Tasmanian red meat industries?

If so, I would like to invite you to participate in an important new project:

Benchmarking Tasmania's sheep and beef industries

- Will produce the first industry-wide benchmarks of the financial performance of Tasmania's wool, sheep-meat and beef industries
 - Will identify the underlying drivers of enterprise profitability
 - Is funded by the Tasmanian Government and Meat and Livestock Australia
 - Will be run over the next three years
 - Is administered by the Tasmanian Institute of Agricultural Research as part of the Red Meat Targets Project.

Benchmarking is a strategic management tool by which you can measure how your business fares across seasons and against your peers. This project will help you to answer questions like 'What drives farm profitability?' and 'How am I going compared to other producers?'

By participating in the project you will:

- Receive confidential financial benchmarking information about your business
- Gain more confidence to make changes to your business where they will have the greatest impact on profitability
- Have the opportunity to compare and discuss the results with your peers, and relate different physical characteristics of Tasmanian farms to financial profitability
- Assist the Tasmanian sheep and beef industries.

How does it work?

In order to understand and better support Tasmania's red meat industries, the Tasmanian Government is subsidising financial benchmarking for up to 300 wool, sheep-meat or beef enterprises. This is through Red Sky Agricultural, an international company specialising in farm performance analysis. The process is:

- You complete a short questionnaire describing your livestock enterprise(s)
- Red Sky Agricultural or participating accountants will process the questionnaire information, and data from your tax accounts
- You are sent your <u>individual benchmarking report</u>
- You can participate in group discussions of benchmarking results.
